SPOT ADMISSION FOR MBBS COURSE 2016-17

A few seats for MBBS Course 2016-17 in this institution under Management and NRI Quota remain unfilled after closing admission as per Second Allotment on 27.09.2016. The management desires to fill these vacancies by spot admission from those who are already in the eligible list of applicants but not considered in the First and Second Allotment in the same category. Aspiring applicants shall report in person before the Principal from 09 AM on 28.09.2016 with fee and all required documents mentioned below. Those who report shall also record their name, time of arrival and signature in the document / register maintained for the purpose at this Office.

.Please note that those who report first will be first served and the admission proceedings will be closed at the time of filling the vacancies or at 4 PM on 29.09.2016, whichever is earlier.

List of Documents / Things to be produced at the time of Admission:

1. SSLC/ 10th standard Certificate.
2. Proof of date of birth.
3. Plus Two or equivalent Certificate.
4. Mark list at the qualifying Examination (Plus Two or equivalent)
5. Transfer Certificate (T.C) from the institution last attended
6. Admit card at the Medical Entrance Examination conducted by Commissioner for Entrance Examinations, Kerala.
7. Mark list at the Medical Entrance Examination conducted by Commissioner for Entrance Examinations, Kerala.

8. Certificate of good conduct from the institution last attended, preferably issued within six months.
9. Document/certificate from the authority, mentioned in the Prospectus, to establish the claim for reservation /privilege, if any, made in column 8 of the application.
10. Community Certificate from Tahsildar / Village Officer in case the candidate requires relaxation in marks as per rules in force.
11. Medical Fitness Certificate.
12. Character & Conduct Certificate in compliance with clause XII b of the Prospectus on "Prohibition of Ragging".
13. Equivalency / Eligibility Certificate of the qualifying examination obtained from Kerala University of Health Sciences by candidates other than those who passed qualifying examination of Kerala Higher Secondary Board, CBSE or ICSE.
14. Migration certificate by candidates passed qualifying examination other than Kerala Higher Secondary Board.
15. Tuition Fee of Rs 11,00,000/- in case of Management Quota and Rs 15,00,000/- incase of NRI Quota , Special Fees of Rs 73,300/- and Hostel and other charges of Rs 1,06,500/- are to be paid for the First Year and Bank Guarantee from a Scheduled Bank agreeing to pay the tuition fee to be paid for the second, third, fourth and fifth year of the course. Those who are unable to obtain Bank Guarantee shall remit the entire amount coverable under bank-guarantee.
16. Security Deposit of Rs 11,00,000/- by cash or DD in the case of Management Quota and Rs 15,00,000/- in the case of NRI Quota.
17. Declaration Form filled and signed by the sponsor (for NRI Quota)
18. Employment Certificate attested by Indian Embassy/Consulate (for NRI Quota)
19. Copy of relevant pages of Passport of the sponsor attested by Indian Embassy/Consulate (for NRI Quota)
20. Visa Copy of the Sponsor attested by Indian Embassy/Consulate (for NRI Quota)
21. Certificate showing relationship of the applicant in the sponsor issued by the Village Officer (for NRI Quota).
22. Ten Passport size photographs of the candidate including one laminated on facing side.

23. Two sets of self-attested photocopies of all the documents/certificates listed above.
